

**RESOLUTION NO. 359**

**AUTHORIZING AN AGREEMENT WITH THE NYS DEPARTMENT OF TRANSPORTATION REGARDING SUPPLEMENTAL AGREEMENT NO. 4 FOR THE OLD RAVENA ROAD (NORTH BRIDGE) OVER CSX RAIL YARD BRIDGE REPLACEMENT PROJECT**

By Public Works Committee and Mr. Clouse:

WHEREAS, A project for the Bridge Replacement of Old Ravena Road over Conrail (North Crossing), BIN 3302980, Albany County, P.I.N. 1754.74 (the "Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 80% federal funds and 20% non-federal funds, and

WHEREAS, The County of Albany desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of Preliminary Engineering, Right-Of-Way Phases and Construction/CI Phases, now, therefore be it

RESOLVED, By the Albany County Legislature, duly convened, does hereby approve the above-subject project, and, be it further

RESOLVED, That the County Legislature hereby authorizes the County of Albany to pay in the first instance 100% of the federal and non-federal share of the cost of Preliminary Engineering, Right-Of-Way and Construction/CI work for the Project or portions thereof, and, be it further

RESOLVED, That the sum of \$7,355,921 (Seven million three hundred fifty five thousand nine hundred twenty dollars and no cents (\$657,721 for Preliminary Engineering; \$428,200 for Right-Of-Way and \$6,270,000 for Construction/CI) has already been appropriated from D5020.4; H522.S1 and H522.S3 and made available to cover the cost of participation in the above phases of the Project, and, be it further

RESOLVED, That the additional sum of \$1,559,000 (One million five hundred fifty nine thousand dollars and no cents) is hereby appropriated from H522.S4 and made available to cover the additional cost of participation in the Construction/CI phase of the Project, and, be it further

RESOLVED, That in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the County Legislature of Albany County shall convene as soon as possible to appropriate said excess amount

upon the notification by the New York State Department of Transportation thereof, and, be it further

RESOLVED, That the County Executive is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the County of Albany with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations thereof that are not so eligible, and, be it further

RESOLVED, That this resolution shall take effect immediately and a certified copy of this resolution shall be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project.
